- HIGHWAY SAFETY
COMMISSION Supervisor Ron Krise said they have been busy installing signs, sweeping roads, and fixing potholes. New signs were installed for the Woodland Park. We are going to go through the analysis that was received from Stiffler McGraw for the bridge replacement. Supervisor Ron Maines said we could not wait two years for the bridge replacement. The township has applied for another DGLVR grant for this year. The Supervisors are looking at paving Spruce and Lake Street once the bridge is taken care of. Egypt Road bridge has a problem with salt water leaking onto the beams causing corrosion. They talked about moving the water line. Tar and chipping of three roads was discussed. Midland gave a proposal but not all supervisors agreed that it would be just as cheap to have someone do the roads as to do themselves. Ron Krise said it would be cheaper and better as the roads need a lot of work and they can't do everything. There is a problem with the mower that needs addressed. The Supervisors agreed that a plan needed to be made for maintaining the roads and they needed to work together to accomplish the plan.
